The late arrival of warmer weather, however, has only inspired me to think of sunny days and this year's 2013 reunion cruise aboard the Celebrity Constellation in December. I know it's only April but our departure date will be here before you know it so for those of you who are procrastinating now is the time.

PRICES: I've spoken with Celebrity this week and they have committed to hold the original prices as long as they can but warned that the ship is filling up. Once our original block of rooms has been filled rates will increase about \$50 for inside & outside cabins and \$75 to \$100 for balconies and suites.

Outside Cabin from: \$384
Veranda (Balcony) from: \$469
Suite from: \$834

Other Costs: Please remember that Gratuities (from \$11 to \$13 per day per person based on your cabin) and Taxes and fees (\$105.89 per person) are not included in the above rates.

HOW TO MAKE A RESERVATION: Our Celebrity POC remains Erika Trivett. Call her at 1-888-727-4907 x13337 to reserve your cabin. If she is not available any other agent at that number will be able to help you. Be sure to ask for the "11th Engineer Battalion Association" reunion, using cruise Group Number 2059484.

NOTE: For those of you on the fence....it's time to get your reservations in to insure the cabin you want.

DEPOSIT: When you make your reservation a credit card deposit will be required. If you want to select your cabin (recommended) a deposit of \$100 per person is required. You can also make a cruise reservation and let Celebrity assign you a cabin later for a deposit of only \$25 per person.

FINAL PAYMENT: Due NLT 25 Sept 2013.

REMINDER: The stop in Mexico means this is classified as an *international* cruise....ALL personnel (except children under the age of 16) must have a current US Passport.

CABIN CREDITS: Celebrity will give each cabin a credit based on the total number of cabins booked in increments of 8 cabins. At present we qualify for a total rebate of "one passenger fare" (\$334). If we book one more cabin, for a total of 16, this will increase to "two passenger fares" or \$668. For 24 cabins it will increase to \$1,002. The max rebate, about \$41.75 for 8, 16 or 24 cabins, will be credited directly to your cabin and can be used as you see fit: to pay gratuities, offset on-board expenses, etc.

EXCURSIONS: The Board of Directors has determined that given the logistics and costs involved we will not be booking any group excursions or meals when on shore in Cozumel or Key West. Instead, all Association meetings and get-togethers will be held on board the ship. This will allow members the freedom to book their own on-shore excursions using Celebrity's extensive offerings. Once these are finalized by the Cruise Line I will publish that information for all travelers. NOTE: If any of you are familiar with Cozumel or Key West I would be interested in getting your feedback and recommendations on what to do (or not do) at each of these locations. I will consolidate your input and present it to the members. Please refer to the attached Info Paper for more information on other cruise details (Meals, Entertainment, Hospitality Room, Meetings, etc.).

Notes from the Treasurer – April 2013 The 11th Engineer Battalion Association is recognized by the IRS as a 503(c)(19) Veterans Organization. I completed and submitted the annual Form 990-N filing for 2012.

I thank President Bill Davis for his positive comments but I have no special skills.

Good news - Bad News by the numbers.

- 84 members are current with their 2013 dues.
- 5 short of the 89 paid members in 2012.
- 13 of the members current with 2013 dues, were either not current or not members in 2012.
- 19 members that were current in 2012 did not renew their membership in 2013.
- 36 individuals in our database did not maintain their membership for either 2012 or 2013.
- 29 members have paid dues for 2014 and beyond.
- 60% of the names in our database are current with their 2013 dues.
- I hope that the members that have let their membership laps are okay.

Ron Smoker and I communicate very frequently and he has been very good in sending out membership cards to those that have paid, so if you do not have a current membership card you are most likely delinquent.

11th EBA Dues Form Revised November 30, 2012 SUBJECT: Information Paper re: Reunion Cruise, 9-14 December 2013 TO: All Members & Guests, 11th Engineer Battalion Association

1. ITINERARY:

a. Day 0 (9 Dec):

Arrive at the port between 1 pm and 3 PM for boarding.

Depart Ft Lauderdale @ 5 PM. Meet on deck (location TBD) for the sail-away party.

Dinner in the main dining room at 6 PM.

Meet & greet in the Hospitality Room (TBD).

- b. Day 1 (10 Dec): At sea, enroute to Cozumel. Association activities (TBD).
- c. Day 2 (11 Dec): Arrive Cozumel ~ 7 AM. Tours/shore excursions. Ship departs at 5 PM.
- d. Day 3 (12 Dec): At sea, enroute to Key West. Leisure time. Association activities (TBD).
- e. Day 4 (13 Dec): Arrive Key West ~ 7 AM. Tours/shore excursions. Depart at 5 PM.
- f. Day 5 (14 Dec): Arrive Ft Lauderdale ~ 6 AM. Depart ship between 8 and 12 Noon.
- **2. CELEBRITY CONSTELLATION.** Launched in 2002 she is currently in dry dock being refurbished. When launched next month she'll head to Europe for the summer then will return to Florida for the winter. She's about 1000 feet long, 100 feet wide and holds just over 2000 passengers. - **3. ARRIVAL:** It is recommended that you arrive in Fort Lauderdale as early as possible on 9 December to avoid complications due to late or missed flights that might impact the boarding process.
- **4. BOARDING:** Typically begins at 12 noon but it is highly recommended that you plan your arrival at the port after 1 PM. This will avoid the early crush and long lines and provide for a more leisurely boarding process. It will still allow plenty of time to get settled in your cabin and tour the ship before departure.

5. MEALS:

- a. All meals are included in the price of the cruise.
- b. There are several venues including a large buffet, a formal dining room and several cafes.
- c. There are also a couple of specialty restaurants which charge up to \$25 per person.
- d. You will be on your own for breakfast and lunch each day.
- e. We are scheduled for dinner at 6 PM each evening in the main dining room.
- f. Celebrity will insure that our tables are all next to each other.

6. ENTERTAINMENT:

- a. The ship offers a main theater and several cabaret-style venues.
- b. These offer everything from Broadway production shows in the theater to comedians, magicians and vocalists/bands in the smaller venues.

- c. There's also a casino, just waiting to take your money, and many other activities from karaoke contests to bingo to art auctions. Something for everyone, just take your pick
- **7. TOURS/EXCURSIONS:** You are free to explore on your own when in port at Cozumel and Key West.
- a. You can choose to take advantage one of the many tours offered by Celebrity (I will list these in the next Panther Press but you can get a heads-up by going to the Celebrity web site)
- b. Or you can spend a leisurely day exploring the port and its surroundings or just chill at poolside.
- c. IMPORTANT: If you leave the ship be sure to get back on time....it will not wait if you are late.

8. ASSOCIATION ACTIVITIES:

- a. Hospitality Room: Celebrity has offered us the use of a Hospitality Room during the cruise but I will not have information on its location or the hours it will be available until we get closer to our departure date.
- b. Business Meeting: To be scheduled during first sea day. Room location and time TBD.
- c. Ladies Luncheon/Tea: To be scheduled for first sea day. Room location and time TBD.
- d. Memorial Service: To be scheduled in the ship's Chapel during the second sea day. Time TRD
- e. Reunion Banquet: Scheduled for the second sea day in concert with dinner that night @ 6 PM.
- f. Option: if there's interest we could have the banquet at one of the specialty restaurants. This would mean an additional charge of \$25 per person.
- g. I have requested a meeting for our group with the Captain and a tour of the bridge. This is pending/TBD.
