I. 2013 Reunion Cruise

- a. **ATTENDEES:** We presently have a total of 14 cabins booked. - b. **ITINERARY:**
- i. Day 0 (9 Dec): Arrive at the port between 1 pm and 3 PM for boarding. Depart Ft Lauderdale @ 5 PM. Meet on deck (location TBD) for the sail-away party. Dinner in the main dining room at 6:30 PM. Meet & greet in the Hospitality Room (TBD).
 - ii. Day 1 (10 Dec): At sea, enroute to Cozumel. Association activities (TBD).
 - iii. Day 2 (11 Dec): Arrive Cozumel ~ 7 AM. Tours/shore excursions. Ship departs at 5 PM.
 - iv. Day 3 (12 Dec): At sea, enroute to Key West. Leisure time. Association activities (TBD).
 - v. Day 4 (13 Dec): Arrive Key West ~ 7 AM. Tours/shore excursions. Depart at 5 PM.
 - vi. Day 5 (14 Dec): Arrive Ft Lauderdale ~ 6 AM. Depart ship between 8 and 12 Noon.
- c. **CELEBRITY CONSTELLATION.** Launched in 2002 she came out of dry dock earlier this year and has just returned from a summer cruise in Europe. She's about 1000 feet long, 100 feet wide and holds just over 2000 passengers. You can learn more about her at these two sites:

- d. **ARRIVAL:** I recommend that you arrive in Fort Lauderdale as early as possible on 9 December to avoid complications due to late or missed flights that might impact the boarding process.
- e. **BOARDING:** Typically begins at 12 noon but it is highly recommended that you plan your arrival at the port after 1 PM. This will avoid the early crush and long lines and provide for a more leisurely boarding process. It will still allow plenty of time to get settled in your cabin and tour the ship before departure.
- f. **MEALS:** All meals are included in the price of the cruise but some "specialty" venues do have a surcharge. Breakfast and lunch are at your leisure in any of the restaurants on board. Dinner each evening will be in the San Marco dining room where we have tables reserved at 6:30 PM. For more on this subject please refer to Information Paper #1, available on the Association website.
- g. **ENTERTAINMENT:** The Constellation offers a main theater and several cabaret-style lounges where there's something going on most every day. The offerings include everything from Vegas/Broadway production shows in the **Celebrity Theater** to comedians, magicians and vocalists/bands in the smaller venues. There's also a casino, just waiting to take your money, and many other activities from karaoke contests to bingo to art auctions. There's something for everyone, just take your pick. - h. **Other On Board Activities.** The great thing about cruising is that there's something for everyone. Outside of entertainment in the theaters and lounges, I've attempted to capture the other activities available around the ship in **Info Paper #3, Subject: Other Activities On Board the Constellation.**

- i. **TOURS/EXCURSIONS:** There are no Association activities planned during port days in an effort to provide you with as much flexibility as possible to explore on your own when in port at Cozumel and Key West.
 - i. You can choose of one of the many tours offered by Celebrity. Check what is offered on their web site.
 - ii. You can spend a leisurely day exploring the port and its surroundings on your own. **NOTE:** If you choose to get out and about on your own please be sure to get back to the ship on time....it will not wait if you are late.
 - iii. Or, with most everybody on shore, you can take advantage of the empty ship and reduced prices for the spa treatments or chill at poolside.

- j. **ASSOCIATION ACTIVITIES:**
 - i. Hospitality Room: Celebrity has agreed to provide us with a Hospitality Room on the following dates/times: Day #1 and Day #3 (both sea days) from 12 noon to 6 PM. Day #2 and Day #4 (both port days) from 4 PM to 6 PM. NOTE: This room will be designated as get closer to our departure date.
 - ii. Business Meeting: To be scheduled during first sea day. Room location and time TBD.
 - iii. Ladies Luncheon/Tea: To be scheduled for first sea day. Room location and time TBD.
 - iv. Memorial Service: To be scheduled in the ship's Chapel during the second sea day. Time TBD.
 - v. Reunion Banquet: Scheduled for the second sea day in concert with dinner that night @ 6:30 PM.

From The Historian:

The 11th Engineer Battalion has a long and distinguished history beginning on 19 March 1917, when it was first constituted and then ordered to active duty at Fort Totten, New York during April-May 1917, coming forward to Fort Benning today.

Just over 60 years ago, a group of soldiers began a quest that culminated in them being crowned the 1953 Softball Champions of the Far East. One of our members, James Loose, was a member of the team at that time and has provided some personal insights into the tournament from start to finish.

The competition began with a round robin contest among the 4 companies in the 11th at that time. A Company proved victorious due to strong pitching and hitting. In Jim’s own words this is how the ultimate team was composed: **“The team had a great pitcher, good defense and pretty good hitting, but they felt some help could be used on their team since several players were nursing injuries. I played shortstop for H&S team and was one of only a few players who got on base against their pitcher, mostly by beating out bunts. The first baseman on the "C" Company team, named Nicholas "Ish" Maruschak, was a long ball hitter; both of us were added to the "A" Company team roster and we were on our way.”**

A Company continued its’ run through the teams in Korea winning the 36th Engineer Group championship followed by the IX Corps and 8th Army championships and finally winning the All Korean Championship by defeating the A Company 772nd MP Battalion team. This team was composed of players all 6’ tall or greater who were known for their long ball hitting, a very strong pitcher and an intimidating demeanor. The 11th team on the other hand was composed of a scrappy group of players known for precision hitting, bunts and a very strong pitcher and they prevailed, beating the 772nd team in 2 straight games, even knocking the 772nd’s pitcher out of the game in the 1st inning of the 1st game!

Then it was off to Japan to meet the teams from Okinawa and Japan to determine the overall champion. Even the trip to Japan had its’ moments including air turbulence and Miss America who attended the same high school as Jim. Jim’s thoughts on the tournament in Japan include this: **“We traveled by train from Tokyo to Camp Sendai arriving Monday evening. On Tuesday the 3 teams, umpires and Camp officers were treated to a magnificent meal featuring "Kobe" beef steaks. This was undoubtedly the best steak I have ever eaten, so tender you could cut it with a fork even though the steaks were at least 1 1/2" thick. The tournament started play on Thursday Sept. 17th, and since I have already emailed copies of the “STARS & STRIPES” I will just recap the games and their results.”**

SUBJECT: Request for Auction Donations

1. We will again be conducting an auction during this year's reunion. 100% of all proceeds go to the Association's account to offset expenses and expand our ability to support active duty 11th Engineer soldiers.
2. This year the Board of Directors (BOD) has approved a recommendation that will open up the auction to the entire Association membership. This will enable us to:
 - a. Accept donated auction items from the entire Membership and
 - b. Permit absentee bidding.
3. I am in the process of preparing the Auction Catalog which will be distributed NLT 60 days prior to the planned reunion and also be posted on the Association website (www.11thengineerbattalionassociation.com).
4. **Auction Procedures.** The Auctioneer shall conduct the auction in accordance with the following procedures:
 - a. Each item brought up for bid shall be identified by its Description and Minimum Bid as published in the Auction Catalog.
 - b. The Auctioneer shall solicit "live" bids from the floor and "absentee" bids from the Treasurer for each item in the Auction Catalog.
 - c. During the Auction the Treasurer shall place bids in the sequence of the bidding from the floor up to the limit of any Absentee Bids in his possession.
 - d. The Treasurer shall notify the Auctioneer if more than one Absentee Bid has been received for any item in the Auction Catalog. In that case the bidding will start at the lower value of the Absentee Bids received provided such bid is at or above the Minimum bid for that item.
 - e. Bidding on all items continues until such time as there is no higher bid and the Auctioneer declares the item "SOLD".
